





FINANCES

The following charts indicate sources of revenue and expenses for NAEMSP™ for the fiscal year that ended June 30, 2005.





One indicator of the financial health of an organization is its capital reserves. NAEMSPTM is pursuing a goal to gradually grow its cash and investments to equal at least one year's expenses. This past year saw progress toward that goal, as NAEMSP's cash and investments grew by more than 8%. They are now equal to more than one half of the organization's projected annual expenses, which are in excess of one million dollars. NAEMSP's financial health is essential so that the attention of the leadership can be dedicated to creating value for the membership.

Three efforts continue to influence NAEMSP's finances. First among them is continually enhancing existing revenue sources. The annual meeting and membership dues are vitally important to NAEMSPTM, continuing to grow and representing more than 63% of yearly revenue. The 2005 annual meeting expenses were under budget, while revenues were in excess of projections. Membership growth, and associated dues income, of more than 12% over the past year also contribute greatly to financial success.

Identifying new opportunities for revenue is very important. Chief among them has been a number of grants and contracts NAEMSPTM has pursued. Each inherently comes with associated expense, but also helps to contribute to the organization's bottom line. During the last fiscal year grants accounted for 31% of NAEMSP's revenue, a relative increase of 5% from the previous year.

Finally, fiscal restraint in the form of responsible spending is crucial. The Board of Directors carefully evaluates the potential impact of all potential expenditures for the effect on the financial health of the organization and value for members. During the last fiscal year the association's management by AMP represented only 17% of the expense budget. Earlier this year the Board of Directors approved a new long term contract with AMP that will continue to ensure outstanding association management with ongoing affordability and fiscal accountability.

NAEMSP's financial health is sound, and continually improving. Thus, the focus is on value for NAEMSP's members and those matters that bring them together.

GRANTS AND CONTRACTS

National Research Agenda

The National Highway Traffic Safety Administration has awarded NAEMSP™ a cooperative agreement in the amount of \$49,992.15 to evaluate the current requirements for exception from informed consent in emergency situations, and to identify those requirements that are serious impediments to conducting EMS research. The cooperative agreement also includes efforts to develop and propose EMS-specific consent strategies as well as appropriate revisions to the existing regulations. The Principal Investigator for this grant is Michael R. Sayre, MD and the Co-Principal Investigators include Lynn White, MS and Lawrence Brown, EMT-P. This grant runs from 7-30-04 through 7-30-07.

A separate Small Conference Grant has been submitted to AHRQ and a decision is expected to be made by February 2006 with the small conference to be scheduled in the early Fall of 2006. The purpose of the small conference is to serve as the impetus for the development of a guidance document to address issues of both consent and ethical conduct for FMS research.

Pediatric Emergency Care Research Workshop

The Health Resources and Services Administration (HRSA), Maternal and Child Health Bureau's (MCHB) Emergency Medical Services for Children (EMSC) program has awarded NAEMSP™ a cooperative agreement in the amount of \$98,073.42 to develop a two-day workshop focusing on pediatric emergency care research. This third Pediatric Research Workshop will be held on January 17-18, 2006 in Tucson, Arizona. It is anticipated that there will be 20 participants and 10 additional slots will be made available for a registration fee of \$150. The Principal Investigator for the Workshop is Kathleen Brown, MD and the Steering Committee consists of Lynn White, MS and Brooke Lerner, PhD. This grant runs through September 26, 2006.

Terrorism Injuries: Information Dissemination and Exchange (TIIDE)

Formerly known as Linkages of Acute Care and EMS to State and Local Health Programs: The Role of Interactive Information Systems for Responding to Events Resulting in Mass Injury

NAEMSPTM was awarded a cooperative agreement in April 2003 to work with federal, state, and local public health agencies to identify currently functioning interactive informational systems between public health agencies, emergency departments, and EMS systems, and to identify linkages of acute care and EMS to state and local injury prevention programs. The work product from this phase of the grant has been published in *Prehospital Emergency Care* and the *Journal of Public Health Management and Practice*.

NAEMSPTM was awarded a second \$100,000 cooperative agreement with the Centers for Disease Control and Prevention on September 30, 2004 for a one-year period to identify model communities that have established linkages between public health and the emergency response community; create a document describing recommendations for best practices; create an inventory of communities with established best practices; create a strong interactive communication system between EMS and public health; and identify characteristics of interactive informational systems.

NAEMSPTM was further awarded an amount of \$25,000 to participate in a cooperative agreement with ACEP and other agencies to work on coordinated linkages of acute care and EMS to state and local injury prevention programs.

A subcontract was entered into between NAEMSPTM and the CDC in the amount of \$61,625 to conduct a one-day conference on "Lessons Learned from Terrorist Attacks" in Nice, France, on September 2, 2005. The objectives of the conference were to assemble an international group of clinicians and administrators to discuss the clinical and system responses to terrorist bombings and disseminate the findings of the conference via available methods including publication in a refereed journal, and attaching links through global organizational web sites. The Writing Team planned to have the document completed by the end of 2005. The conference was attended by 22 international participants.

NAEMSPTM was awarded an additional \$50,000 for the fiscal year running from September 30, 2005 through September 30, 2006, to continue working on the objectives of the original Cooperative Agreement and will be redirecting approximately \$69,000 from the prior year. The project has an expiration date of September 29, 2007. The total funding to date is \$236,624.

The principal investigator for this project is Robert O'Connor, MD, MPH and the Co-Principal Investigator is E. Brooke Lerner, PhD. Writing Team members include Kathy Brinsfield and Richard Schwartz.

Medical Directors Distance Education & Mentoring Program

Formerly known as Medical Response to Terrorism/National Disaster Life Support Integration Project

NAEMSPTM is working in conjunction with the Critical Injury Trauma Foundation on this project. Bethany Cummings, DO and Douglas Kupas, MD are the Co-Principal Investigators. The main focus is on reformatting the Medical Response to Terrorism course to an on-line interactive structure as a module in the NHTSA/NAEMSPTM/CITF on-line EMS Medical Director Course. There will also be a review of the module by EMS physicians and educators for level of knowledge and applicability in on-line format. Another piece of the grant will be the on-line pairing to a mentor. NHTSA recently provided NAEMSPTM with a no cost modification extending the timelines to November 30, 2006. The original funding was for \$150,000 and the remaining balance is approximately \$137,000. The steering committee is currently looking at individuals to constitute their task force and the administrative team will conduct a half day meeting in Tucson, Arizona, in conjunction with the NAEMSPTM annual conference.

Technology and EMS Project

Formerly known as ITS Grant

NAEMSPTM was awarded a cooperative agreement from the National Highway Traffic Safety Administration covering a two year period in the amount of \$300,000. The purpose of this agreement is to implement the *Recommendations* for ITS Technology in Emergency Medical Services to increase national medical community involvement in the planning and implementation of ITS technology. The Co-Principal Investigators for this project are Robert Domeier, MD and Bob Bailey, MA. A meeting of the Technical Consultation Committee was held in Fairfax, VA on April 18-19, 2005. The task force continues to work on formulating the information generated from that meeting.

Public Health Cooperative Agreement

NHTSA has awarded NAEMSPTM with a Cooperative Agreement in the amount of \$100,000, to develop guidance for local EMS medical directors and local public health directors to promote closer coordination between the two entities and to suggest some key opportunities for collaboration at the local level. This project arose from a recommendation made by the NAEMSP's Public Health Committee. The focus of the Public Health Grant will be to improve the national EMS system by creating and documenting ideas, recommendations and guidance concerning the integration of EMS with the public health system. NAEMSPTM will work on this project in cooperation with the National Association of County and City Health Officers (NACCHO). The Principal Investigator for the Cooperative Agreement is Joseph Sabato, Jr. The administrative team is in the process of selecting members to be on the working committee and anticipates having an initial meeting in Spring, 2006. The contract runs through September 15, 2006.

PUBLICATIONS

Prehospital Emergency Care (PEC)

2005 saw the completion of Volume 9 of *Prehospital Emergency Care* (PEC). It was a year of change, as this was the first volume of PEC published together with our new publisher, Taylor and Francis. While a few problems did occur, overall the transition went well. Volume 9 was 476 pages total. Some highlights of the volume were:

- Introduction of new sections, including Military Medicine, State EMS Systems, and Advocates for EMS.
- Published "focus" pieces, including Focus on Pediatric Pain Management, Focus on Airway Management, Focus on Patient Assessment, and Focus on EMS Safety.
- Manuscript submission increased over 2004.

The National Association of EMTs (NAEMT) now recognizes PEC as its "Official Journal". This was announced at their annual meeting in New Orleans, in August 2005. NAEMT members are eligible for a reduced subscription rate, which will hopefully increase PEC's subscription base.

PEC will be implementing an electronic submission and manuscript review process in 2006. There is ongoing exploration of the possibility of publishing PEC on a bi-monthly basis instead of quarterly. In order to proceed in 2007, a decision must be made by June 2006.

Finally, Liz Troy, who had been with PEC from its inception, is no longer doing work for the journal. The demands of her current job with Wyeth made it impossible to continue the freelance work she had been doing. PEC's editor and staff will miss Liz, to be sure.

NAEMSPTM News

Under the direction of editor Cai Glushak, MD, NAEMSP's bi-monthly newsletter provides timely information to the organization's membership. During 2005, *NAEMSP™* News converted to an electronic delivery format. Members receive the newsletter highlights with hyper-links via e-mail. A hard copy can still be obtained via request to the NAEMSP™ executive office. Further, *NAEMSP™* News is archived on the NAESMP website (www.naemsp.org).

Improving Quality in EMS

Robert Swor, DO and Ronald Pirallo, MD led the development and edited *Improving Quality in EMS*, second edition. The 246 page, 12-chapter book was published in 2005 as a must-have follow-up and update to the first edition. It is available to NAEMSPTM members from Kendall/Hunt Publishing at \$29.95 (www.kendallhunt.com/naemsp).

Prehospital Systems and Medical Oversight, Fourth Edition

NAEMSPTM began the search for an editor-in-chief for the fourth edition of its textbook, *Prehospital Systems and Medical Oversight*. A position description is posted on the NAEMSPTM website (www.naemsp.org). Tentative plans are publication of the new edition some time in 2007.



2005 Annual Meeting

The 2005 NAEMSP™ Specialty Workshops, Scientific Assembly and Trade Show was held at the Registry Resort in Naples, Florida, on January 13-15, 2005. The meeting was chaired by Dr. Ted Delbridge who was assisted by all of the members of the Program Committee.

- Pre-conference sessions included EMS-C Pediatrics Emergency Care Research Workshop, NAEMSP[™] National EMS Medical Directors Course and Practicum[™], Legal Aspects of EMS Systems Management, Incident Command System, and CONTOMS Medical Director's Course.
- Twenty-seven faculty members collaborated to provide 24 hours of general didactic sessions.
- Researchers made 18 oral abstract presentations and 78 poster abstract presentations.
- Dr. Daniel Spaite presented the C. J. Shanaberger Memorial Lecture and Keynote Address.
- At an outdoor static display, representatives of Carolinas Medical Center provided guided tours of their mobile hospital.
- Six hundred and thirty-two members, guests, and exhibitors attended the 2005 annual meeting.
- Forty-four exhibitors provided financial support for the association's education program by attending the annual meeting and purchasing exhibit space.
